**VI. Homeowner Affidavit**

When setting a HUD mobile home or a premanufactured home on private property, a permit must include the application fee, service, feeder and a final inspection.

General: Electrical work shall not be started until the application for permit has been filed with the Bureau of Construction Codes. All installations shall be in conformance with the Michigan Electrical Code. No work shall be concealed until it has been inspected.

- All permits require a \$50 non-refundable Application Fee.
- There is an annual Contractor Registration Fee of \$35.  
Required paperwork for registration  
-Copy of current Contractor/Master License  
-Copy of Drivers License for contractor/applicant  
-Copy of Insurance
- There will be a DOUBLE PERMIT FEE assessed for all requested inspections prior to obtaining appropriate permits, and/or work done without the benefit of required permits.
- An inspection outside of normal business hours (minimum charge of 2 hrs) is \$50 per hour.
- When an outside consultant is used for plan checking and inspections extra fees may apply.

**Where to Submit Application:** Permits can be turned into the township hall at 1677 Ready Rd, Carleton, MI 48117. Or you can mail the permit to Ash Township, P.O. Box 387, Carleton, MI 48117. **IF YOU WOULD LIKE A COPY OF YOUR PERMIT PLEASE SEND AN ENVELOPE WITH A RETURN STAMP.**

**Expiration of Permit:** A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN 180 DAYS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED. THE CHARGE TO RE-OPEN A CLOSED PERMIT IS \$50.00.**
